Eligibility Criteria:

Any retired Nursing Supervisor (Supervisory level) from PSUs / Autonomous Organizations/Central Government / State Government / Statutory Bodies etc., meeting the following eligibility criteria can apply:

i. **Age (as on 01.04.2025):** The applicant should have attained 60 years of age and should not be more than 64 years of age.

Note:

- Applicants retired under VRS Scheme shall be considered only after attaining 60 years of age.
- Exception for Ex-Servicemen for the lower age, however duration of engagement for Ex-Servicemen shall be 5 years or till 65 Years of age, whichever is earlier.

ii. Qualification Requirements:

The applicant must possess Diploma Nursing / B.SC Nursing qualification.

iii. Experience (as on 01.04.2025):

The applicant should possess the following post qualification experience

 Minimum 15 years of experience in Nursing, excluding teaching experience post attaining Diploma / B.SC Nursing

Selection Process:
