- c. **Educational Qualification:** - Candidates applying for the above posts should have their MBBS Degree recognized by the Medical Council of India.
 - d. **UPPER AGE LIMIT: 65 years (as on 01/05/2026)**, however, the age limit may be relaxed up to 70 years with specific approval from the Competent Authority.
 - e. **TENURE:** The engagement is purely on Temporary basis for a period of 01(One) Year and payable on hourly basis. Subsequent renewal(s) will be limited to a period of maximum 3 years, subject to satisfactory performance and at the discretion of the Management. The tentative date of joining will be in the **first week of July- 2026**.
 - f. **WORKING HOURS:** The working hours for PTMC will be for a minimum of 03 (three) hours and maximum of 06 (six) hours in a day for maximum 05 (five) days in a week (Monday to Friday). There will be no working on BHEL declared holiday for Kolkata.
