#### 2. UPPER AGE LIMIT

- 65 years (as on 01/10/2023), however, the age limit may be relaxed up to 70 years with specific approval from the Competent Authority.

#### 3. TENURE

- The engagement is purely on Temporary basis for a period of 01(One) Year and payable on hourly basis. Subsequent renewal(s) will be limited to a period of maximum 3 years, subject to satisfactory performance and at the discretion of Management.
- There will be notice period of one month, on either side, for discontinuing the part time engagement.

#### 4. WORKING HOURS

- The working hours for PTMC will be for minimum 3 hours and maximum of 06 hours in a day. 6 hours of working will be in 2 shifts of 3 hours each by 2(Two) PTMCs.
- Management has the right to change the working hours based on requirement and availability of candidates.

- In case of local travel, (up to 30 KMs one-way), conveyance charges may be given on actual basis, with the upper ceiling of Rs. 4500/- per month and beyond 30 KMs one-way, with an upper ceiling of Rs. 6000/- per month on case to case basis.
